

Arrival on	The ARU East Road campus is about a ten-minute walk from the centre of Cambridge and landmarks such as the Guildhall and Market Square. The Lord						
foot/train	Ashcroft Building (LAB) is just around the corner on Broad Street (past main entrance on East Road).						
	Trains run frequently between Cambridge and London, Ipswich, Peterborough, King's Lynn, Birmingham, and Stansted Airport.						
	If you're travelling from Heathrow, Gatwick, or via Eurostar, head for King's Cross or Liverpool Street stations in London; you can catch trains to						
	Cambridge from there.						
By car	Cambridge is currently running four Park and Ride bus routes.

	Parking in the city is difficult. You can try the Grafton Centre Carpark (East Rd, Cambridge CB1 1PS, 5 minutes walk from ARU), but we recommend not to drive into Cambridge!
